- * Supervision of children. Early registration of dojo seniors (adults) to be responsible for a room of children. This takes away the need for parents to come.

- b. Tournament Feedback-
 - Low on volunteers table officials low, due to more people moving into referee roles
 - Possible way to increase participation is to build junior squad class and invite parents to practice table official skills during match practice days.
 - Marshalling Ian did well for the first time.
 - Canteen we think it went well.
 - Promo for October tournament. Prepare handouts for all competitors at the August GC tournament.
